#### Important Changes

#### Recipient Agency (RA) Responsibilities

Place their own direct delivery and processing requisitions in WBSCM.

#### **WBSCM Access for Co-ops**

- TDA does not have a direct contractual relationship with Co-ops.
- TDA <u>cannot</u> provide Co-ops with WBSCM access.

#### **WBSCM Access for FSMCs**

- TDA will provide WBSCM access to RAs.
- When appropriate, TDA will provide an RA instructions for FSMC access.


