Funding Opportunities

Studies of farm to school-related activities consistently show these efforts have positive impacts on food and nutrition-related knowledge; most studies also suggest a positive relation between farm to school-related activities and healthy food selection during school meals, nutrition self-efficacy, and a willingness to try fruits and vegetables. USDA is Currently Conducting the 2018 Farm to School Census

School districts should be on the lookout for an email from ABT Consulting to complete the 2018 Farm to School Census. By taking the survey, you help USDA assess the growth of farm to school across the nation. This is the first survey since 2015 and USDA has put together the **Census preparation survey** to help contracting entities (CEs) complete the survey answers.

The 2018 Census will ask questions similar to those asked in the past, including the following:

- What is the CE's definition of local?
- How much money is spent on local food purchases annually?
- What local products are most commonly purchased?
- · Where are the local foods from?
- What are the biggest challenges and benefits of engaging in farm to school?
- How many edible school gardens are in the district?
- How many salad bars are in the district?
